Zinc	18.1%
Manganese	9.3%
Copper	2.3%
Cobalt	0.25%
Iodine	0.30%
Chromium	0.16%

INGREDIENTS:

Zinc Hydroxychloride, Manganese Hydroxychloride, Basic Copper Chloride, Cobalt Carbonate, Calcium Iodate, Chromium Propionate, Starch, Organic Vegetable Oil

DIRECTIONS FOR USE:

For best results, it is recommended that a nutrition professional be consulted to determine an optimized feeding level to meet animal requirements. Mineral antagonists should also be taken into consideration when determining required feeding level.

PHYSICAL DESCRIPTION:

Micro 5 Cr is an odorless, brown, granular powder.

STORAGE:

Store the product in a dry place away from any moisture. Keep bag tightly closed or sealed when not in use.

CAUTION:

As is the case with any trace mineral ingredient, excessive levels of Zinc Hydroxychloride, Manganese Hydroxychloride, Basic Copper Chloride (Copper Hydroxychloride), and cobalt can be toxic. Do not feed to sheep or related species. Follow label directions. Chromium from all sources of supplemental chromium cannot exceed 0.2 part per million of the complete feed for broiler chickens and swine and 0.5 part per million of the complete feed for cattle, cannot exceed 4 mg per horse per day.

DANGER:

Harmful if swallowed. Harmful if inhaled. May cause allergy or asthma symptoms or breathing difficulties if inhaled. May cause an allergic skin reaction. May cause damage to organs.
